PaCT Advantage is an easy to use resource management diagnostic that focuses on building and implementing the foundations of an effective management system for water, energy and chemicals. It builds on a continuous improvement methodology, engaging senior management and decision-makers of the factory to deliver ongoing savings through enhanced business practices embedded within the organization's management system.

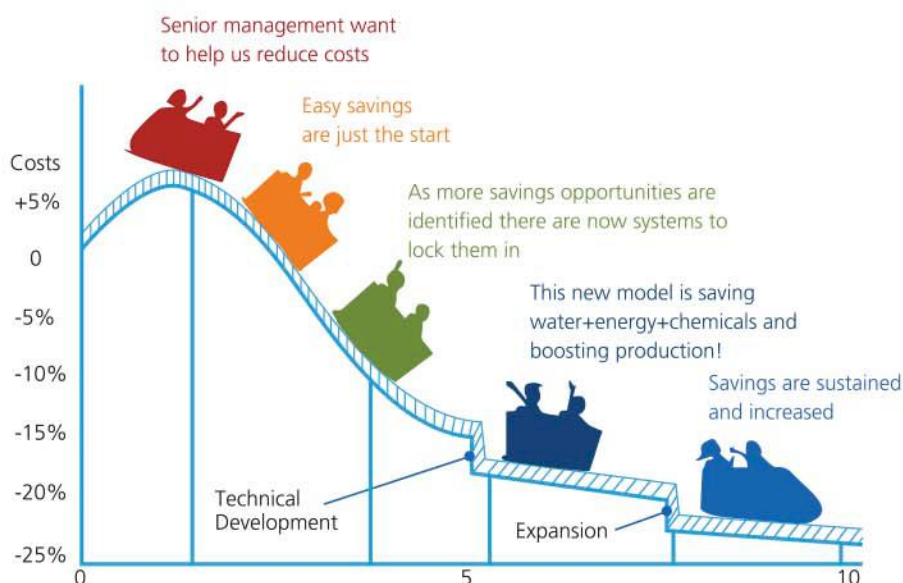
PaCT Advantage diagnostic:

- Identifies a factory's present strengths and weaknesses
- Aimed at senior managers and decision-makers
- Provides a rating of water, energy and chemical management performance on 21 topics in 12 core areas
- Identifies the 10 highest priority recommended actions to improve water, energy and chemical management
- Focuses on actions that can bring high returns with low / no investment
- Co-ordinates the elements that are necessary to make resource management successful

The key feature of PaCT Advantage is the short but highly effective management diagnostic, which takes only 60-90 min to complete. At the end of the diagnostic session, factory management receives an immediate report that includes a review of overall performance in water, energy and chemical management and identifies opportunities and gaps in procedures or policies.

Here's how it work

Most textile wet processing factories do not have resource management systems that allow them to systematically track use of resources. As a result, factory management is unaware of the 'true' cost of resource use, and thus fail to make resource management a strategic business priority.



PaCT Advantage addresses this gap by integrating water, energy and chemical practices within your organization and tying together all the elements necessary to make the resource management program a highly successful one. It works by offering support to factory management in implementing recommendations from the diagnostic (e.g., developing a system to track Key Performance Indicators (KPI)) and continue the diagnosis to benchmark progressions. In addition, the tool enables to benchmark factories of a similar type.

More than a technical audit

Technical audits are a 'snapshot' on any given day; they traditionally comprise of water, energy and chemical assessments identifying opportunities to reduce consumption. They are solely focused on cost drivers, with no strategic action plans for continuous improvement. In spite of improvement opportunities, rate of implementation of the identified savings opportunities is often poor (~15-30%). This is because engineers often have limited authority to drive implementation. As a result, factories continue to incur high costs.

PaCT Advantage is not a technical audit. It engages top executives in water, energy and chemical management to investigate the underlying causes for the current performance of the factory. It looks beyond water, energy and chemicals and addresses elements such as training and awareness, KPI's, roles and responsibilities, operations and maintenance practices, financial decision making, leading to broader management engagement and increased savings.

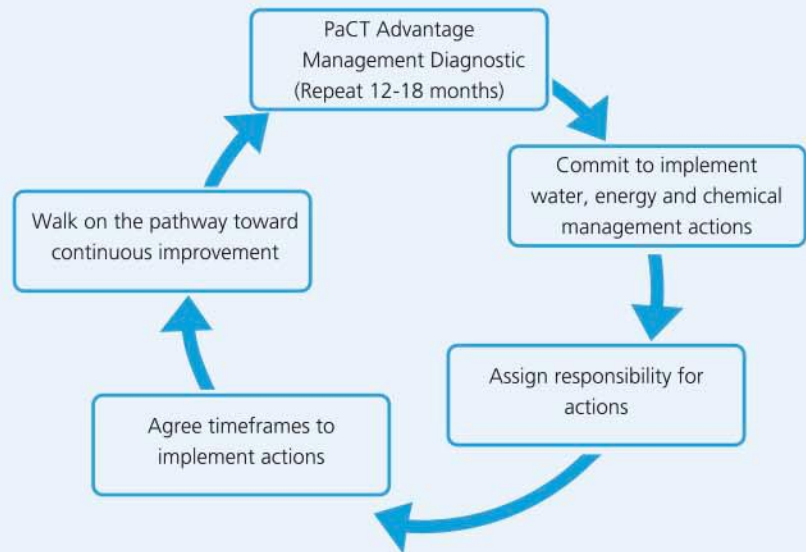


Take Advantage
