COVID-19 Supply Chain System (CSCS)

- Supply Chain Task Force co-chaired by WHO and WFP
- Convened to establish the CSCS
 - Task Force
 - Purchasing Consortia
 - Control Tower
 - Supply Portal purpose-built to facilitate the requests for critical supplies and <u>is able to</u> receive requests for items in the catalogue
 - Every approved stakeholder who has an active role in the COVID-19 preparedness and response action plan can sign up and be a requestor (Government agencies, UN agencies, NGOs, and other partners)




Three-month supplies plan

Based on the country needs for COVID-19 preparedness and response, a 3-month supplies plan has been endorsed by the Government of Bangladesh and circulated to all agencies and partners.

- Biomedical Equipment & Consumables (clinical management / medical equipment)
- Diagnostics (sample collection and test kits)
- Personal Protective Equipment (gown, apron, masks, eye protection, etc.)






Biomedical Equipment &

 Diagnostics (sample collection and test kits) – 12,557,827

• Personal Protective Equipment (gown, apron, masks, eye protection, etc.) - 48,449,575

Personal Protective Equipment

Items in the catalogue:

- Apron
- Gloves (surgical)
- Gloves (examination)
- Face shield
- Respirator mask (N95 / FFP2)

- Medical / Surgical mask
- Gown
- Goggles
- Bio Hazard Bag



Personal Protective Equipment

Items NOT in the catalogue:

- Hand sanitizer
- Coverall
- **Heavy-duty gloves**
- Hexi sol / Alcohol based hand-rub
- Liquid Soap
- Body bag (adult / child) Medical gas system

- Surgical cap
- Closed colored bin
- Sodium hypo chloride / hypochlorite
- Disinfectant sprayer
- **PCR** gloves (powder free)



How can a local supplier be involved in the <u>local</u> supply chain?

 Local suppliers can do business with any of the buying agencies to supply PPEs (catalogue/non-catalogue)

How do you get certified?

- Five (5) enlisted laboratories in the country for certification
- Minimum testing parameters in place



How can a local supplier be involved in the <u>local</u> supply chain?

Any interested supplier can reach-out through WFP, being the UN Coordinator for Logistics and Procurement Pillar. Your information will be disseminated to all member agencies (vice-versa).




AOB: Inventory Management
